3. **L12-252 - Assumption Parish, LA 70 Lee Drive Gravity Drainage District No. 14** - \$60 Annual Parcel Fee, 10 years, 2013-2022, (1) constructing and maintaining levees, levee drainage, flood protection, hurricane flood protection, and all purposes incidental, including paying compensation for the exercise of permanent or temporary servitudes and (2) funding proceeds into Bonds.
4. **L12-239 - East Baton Rouge Parish, Metropolitan Council of the Parish of East Baton Rouge and City of Baton Rouge, Mosquito Abatement and Rodent Control District** - 1.23 mills tax, 10 years, 2014-2023, (1) purchase, maintain and operate machinery, facilities and equipment necessary and useful in the eradication, abatement or control of mosquitoes, other arthropods of public health importance and rodents, and (2) maintaining and providing for adequate administrative and support staff.
5. **L12-248 - Rapides Parish Police Jury, Fire Protection District No. 2, Service Area No. 1** - 16.31 mills tax, 2012-2020, acquiring, constructing, improving, maintaining and operating fire protection and emergency medical service facilities and other firefighting or emergency medical service equipment.

11. **L12-245 - St. Landry Parish School Board** - Not exceeding \$3,500,000 Revenue Anticipation Notes, Series 2012, not exceeding 4%, mature no later than June 30, 2013, current expenses.
12. **L12-226 - St. Tammany Parish, Recreation District No. 11** - Not exceeding \$1,000,000 Limited Tax Certificates, Series 2012, not exceeding 5%, not exceeding 10 years, acquiring, constructing or improving parks, playgrounds, recreation centers and other recreational facilities, together with the necessary furnishings and equipment.

13. **L12-225 - Tensas Parish Law Enforcement District** - Not exceeding \$1,250,000 Revenue Anticipation Notes, not exceeding 6%, mature on or before June 30, 2013, current expenses.

19. **L12-242 - Bossier Parish, City of Bossier City** - Not exceeding \$5,500,000 Utilities Revenue Refunding Bonds, Series 2012, not exceeding 2.75%, mature on or before October 1, 2022, refunding Utilities Revenue Bonds, Series 1997 and 2001.
20. **L11-454A - Calcasieu Parish, Waterworks District No. 4, Ward 4** - Not exceeding \$2,000,000 Water Revenue Bonds, Series 2012, not exceeding 5%, not exceeding 20 years, establish, acquire, construct, improve, extend and maintain a waterworks system, including such treatment facilities, with all necessary equipment and installations, including such extensions as may be proper.
21. **L12-250 - Evangeline Parish School Board** - Not exceeding \$2,215,000 School Improvement Refunding Bonds, not exceeding 3%, mature no later than August 1, 2019, refunding all or any portion of School Improvement Bonds, Series 2004.
22. **L12-255 - Lafayette Parish, City of Carencro** - Not exceeding \$1,150,000 Public Improvement Sales Tax Refunding Bonds, not exceeding 4%, mature no later than April 1, 2018, refunding all or a portion of Public Improvement Sales Tax Bonds, Series 1998 and Public Improvement Sales Tax Refunding Bonds, Series 2005.
23. **L12-141 - Lafourche Parish School Board, Consolidated School District No. 1** - Not exceeding \$23,000,000 General Obligation School Refunding Bonds, not exceeding 4%, mature no later than March 1, 2029, refunding all or any portion of General Obligation School Bonds, Series 2003 and/or Series 2004.
24. **L12-244 - Lafourche Parish, Water District No. 1** - Not exceeding \$3,750,000 Water Revenue Refunding Bonds, not exceeding 4%, mature on or before January 1, 2023, prepaying and refunding Water Revenue Bonds, Series 2003.

29. **L12-254 - Ouachita Parish, City of Monroe** - Not exceeding \$32,000,000 Utility Refunding Bonds, Series 2012, not exceeding 3.25%, mature no later than July 1, 2027, (1) refunding Utility Revenue Bonds, Series 2001, 2003 and 2005 and (2) funding a debt service reserve fund, if required.
30. **L12-227 - St. Bernard Parish Council** - Not exceeding \$38,000,000 Sales Tax Refunding Bonds, in one or more series, not exceeding 5%, no later than March 1, 2024, refunding all or any portion of Sales Tax Bonds, Series 2003 and/or 2004.
31. **L12-224 - St. Martin Parish, City of St. Martinville** - Not exceeding \$2,550,000 Street Improvement Refunding Bonds, Series 2012, not exceeding 4%, mature no later than April 1, 2024, refunding Street Improvement Bonds, Series 2008.
