1. Call to order and roll call.
2. Approval of the minutes of the March 18, 2013 Ad Hoc Election Subcommittee meeting.

**LOCAL GOVERNMENTAL UNITS - ELECTIONS (October 19, 2013)**

3. **L13-283 - Beauregard Parish, Fire Protection District No. 1** - 4.97 mills tax, 10 years, 2014-2023, (1) constructing, acquiring, improving, maintaining and operating fire protection facilities and equipment; (2) paying the cost of obtaining water for fire protection purposes, including tankers and fire trucks; (3) paying the cost of charges for fire hydrant rentals and service.
4. **L13-280 - Beauregard Parish School Board, Parishwide School District** - 21.35 mills tax, 10 years, 2014-2023, (1) operating and maintaining public elementary and secondary schools, including the cost of acquiring and maintaining equipment and supplies for educational and instructional service; (2) paying the salaries of personnel; (3) paying the cost of acquiring library books.
5. **L13-290 - Beauregard Parish Police Jury, Road District No. 1-A** - 24.36 mills tax, 10 years, 2013-2022, (1) constructing, improving, and maintaining Parish roads and bridges and (2) acquiring the necessary equipment.
6. **L13-322 - Caddo Parish Commission** - Amendment to Paragraph A, Section 3-01 of Article III of the Home Rule Charter to extend the commissioners' consecutive elected terms limit from three to five years.
7. **L13-293 - Caddo Parish Commission** - Not exceeding \$23,390,000 General Obligation Bonds, in one or more series, not exceeding 6%, not exceeding 20 years, capital improvements, including constructing, acquiring and/or improving (a) roads, streets and bridges, (b) drains and drainage facilities (c) public buildings and facilities and (d) parks and recreational facilities, including acquiring all necessary land, equipment and furnishings.
8. **L13-282 - Caldwell Parish, Town of Columbia** - 3 mills tax, 10 years, 2015-2024, constructing, maintaining and improving public streets.
9. **L13-256 - Catahoula Parish, Enterprise Recreation District** - 15 mills tax, 10 years, 2015-2024, acquiring, constructing, improving, maintaining and operating recreational facilities, including necessary equipment.
10. **L13-294 - Claiborne Parish Police Jury** - 2.71 mills tax, 10 years, 2015-2024, operating, repairing, maintaining and equipping the Parish Courthouse, Jail and other Buildings, including paying cost of utilities.
11. **L13-312 - Claiborne Parish Police Jury** - 1/8% sales tax, 7 years, beginning January 1, 2014, conservation and development of natural resources for agricultural, commercial, residential or other purposes, including surface and ground water, promoting safety on lakes and waterways both within and without the Parish, equipment and improvements necessary, to be administered by the Claiborne Parish Watershed District pursuant to an intergovernmental agreement with the Parish.

12. **L13-313 - Claiborne Parish Police Jury** - Authorization of an additional homestead exemption for certain disabled veterans and surviving spouses.
13. **L13-295 - East Baton Rouge Parish, Central Fire Protection District No. 4** - 10 mills tax, 10 years, 2015-2024, (1) development, operation and maintenance of the Fire District; (2) paying cost of obtaining water, including charges for fire hydrant rentals and service.
14. **L13-263 - East Baton Rouge Parish, Metropolitan Council of the Parish of East Baton Rouge and City of Baton Rouge** - 3.13 mills tax, 10 years, 2015-2024, provide funds to the Department of Emergency Medical Services to pay the operation and maintenance costs and expenses of providing emergency medical services.
15. **L13-261 - East Baton Rouge Parish, Metropolitan Council of the Parish of East Baton Rouge and City of Baton Rouge, Brownsfield Fire Protection District No. 3** - 10 mills tax, 10 years, 2015-2024, (1) development, improvement, operation and maintenance of the fire protection facilities; (2) paying salaries and benefits of fire district personnel; (3) paying the costs of obtaining water for fire protection purposes and (4) paying the cost of fire hydrant rentals and service.
16. **L13-262 - East Baton Rouge Parish, Metropolitan Council of the Parish of East Baton Rouge and City of Baton Rouge, Brownsfield Fire Protection District No. 3** - 10 mills tax, 10 years, 2014-2023, (1) development, improvement, operation and maintenance of the fire protection facilities; (2) paying salaries and benefits of fire district personnel; (3) paying the costs of obtaining water and (4) paying the cost of fire hydrant rentals and service.
17. **L13-304 - Franklin Parish, Hospital Service District No. 1** - 13 mills tax, 25 years, 2014-2038, constructing, improving, equipping, operating and maintaining hospital facilities.
18. **L13-289 - Grant Parish, Hospital Service District No. 1** - 2.31 mills tax, 10 years, 2013-2022, (1) maintenance and the general expenditures needed in the everyday operation of the Hospital; (2) other miscellaneous expenses incurred in operation.
19. **L13-301 - Grant Parish School Board** - 11.38 mills tax, 10 years, 2014-2023, (1) 75% for the purpose of paying salaries and benefits of teachers; (2) 25% for the purpose of paying salaries and benefits of support staff.
20. **L13-292 - Iberia Parish, City of New Iberia** - 4 mills tax, 20 years, 2013-2032, paying debt service obligations.
21. **L13-281 - Iberia Parish School Board, Parishwide School District** - Not exceeding \$50,000,000 General Obligation Bonds, in one or more series, not exceeding 8%, not exceeding 20 years, (1) acquiring and/or improving lands for building sites and playgrounds, including construction of necessary sidewalks and streets; (2) purchasing, erecting and/or improving school buildings and other related facilities; (3) acquiring necessary equipment and furnishings and (4) specially for those facilities, technology and security initiatives in the "Capital Improvement Plan" approved by the School Board on June 18, 2013.
22. **L13-307 - Jefferson Davis Parish, Broadmore Gravity Drainage District** - 8.8 mills tax, 10 years, 2014-2023, improving, constructing, maintaining and operating gravity drainage works.
23. **L13-309 - Jefferson Davis Parish, Fire Protection District No. 1** - 10.49 mills tax, 10 years, 2014-2023, (1) constructing, acquiring, improving, maintaining and operating fire protection facilities and equipment and (2) paying the cost of obtaining water.
24. **L13-310 - Jefferson Davis Parish, Fire Protection District No. 3** - 3.59 mills tax, 10 years, 2014-2023, (1) constructing, acquiring, improving, maintaining and operating fire protection facilities and equipment and (2) paying the cost of obtaining water.

25. **L13-311 - Jefferson Davis Parish, Fire Protection District No. 4** - 5 mills tax, 10 years, 2014-2023, (1) constructing and improving fire protection facilities and (2) acquiring fire trucks and other equipment.
26. **L13-314 - Jefferson Davis Parish, Fire Protection District No. 5** - 10 mills tax, 10 years, 2014-2023, acquiring, constructing, improving, maintaining and operating fire protection facilities and equipment.
27. **L13-315 - Jefferson Davis Parish, Grand Marais Gravity Drainage District** - 6.7 mills tax, 10 years, 2014-2023, constructing, improving, maintaining and operating gravity drainage works.
28. **L13-308 - Jefferson Davis Parish, Gravity Drainage District No. 1, Sub-Drainage District "A"** - 11.39 mills tax, 10 years, 2014-2023, acquiring, constructing, improving, maintaining and operating gravity drainage works.
29. **L13-316 - Jefferson Davis Parish, Gravity Drainage District No. 9** - 9.21 mills tax, 10 years, 2014-2023, improving, constructing, maintaining and operating gravity drainage works.
30. **L13-318 - Jefferson Davis Parish Police Jury, Road District No. 10, Wards 1, 2 & 3** - 11.33 mills tax, 10 years, 2014-2023, except the City of Jennings and the Town of Lake Arthur, improving and maintaining public roads.
31. **L13-317 - Jefferson Davis Parish Police Jury, Road District No. 12, Wards 6, 7 & 8** - 10.94 mills tax, 10 years, 2013-2022, except the Town of Welsh, improving and maintaining Parish roads.
32. **L13-291 - Madison Parish, Mound Fire Protection District No. 1** - \$125 annual parcel fee, 5 years, 2013-2017, paying costs of fire protection services, including cost of acquiring, operating and maintaining equipment and facilities.
33. **L13-286 - Morehouse Parish, Fire Protection District No. 1, Ward 8** - 1.94 mills tax, 10 years, 2014-2023, buying, operating, and maintaining of fire protection equipment.
34. **L13-275 - Orleans Parish, City of New Orleans** - Amendment to Article V, Chapter 3, Section 5-301 of the Home Rule Charter relative to the organization, composition and appointment of the Sewerage and Water Board.
35. **L13-278 - Orleans Parish, City of New Orleans** - Amendment to Article IV, Section 4-102(2)(a) and Section 4-704 of the Home Rule Charter, effective January 1, 2014, to abolish the Board of Electrical Examiners, the Board of Examiners of Operating Engineers, and the Board of Mechanical Examiners from the Department of Safety and Permits.
36. **L13-279 - Ouachita Parish Police Jury, Road Lighting District No. 45** - \$80 annual service charge, plus a collection charge of \$4.00 per parcel, 5 years, 2014-2018, (1) paying utility charges for road lighting and (2) maintaining and operating road lighting facilities and equipment.
37. **L13-303 - Rapides Parish Police Jury** - 2.06 mills tax, 10 years, 2015-2024, construction and maintenance and operating expenses of the Juvenile Community Correction Center, Juvenile Detention Center, Juvenile Home Care and Juvenile Shelter Care Center known as "RENAISSANCE."
38. **L13-302 - Rapides Parish Police Jury, Fire Protection District No. 7** - 26.04 mills tax, 10 years, 2015-2024, (1) constructing, operating and maintaining fire protection facilities and (2) paying the costs of obtaining water.

39. **L13-296 - Rapides Parish Police Jury, Fire Protection District No. 11** - 33.16 mills tax, 10 years, 2015-2024, (1) constructing, operating and maintaining fire protection facilities and (2) paying the costs of obtaining water.
40. **L13-298 - Rapides Parish Police Jury, Fire Protection District No. 16** - 15 mills tax, 10 years, 2014-2023, (1) acquiring constructing, improving, maintaining and/or operating fire protection facilities, and equipment (2) paying the cost of obtaining water.
41. **L13-299 - Rapides Parish Police Jury, Road District No. 1A** - 25.03 mills tax, 10 years, 2015-2024, constructing, maintaining, and keeping in repair the public roads, highways, and bridges.
42. **L13-300 - Rapides Parish Police Jury, Road District No. 9B** - 10.98 mills tax, 10 years, 2014-2023, constructing, maintaining, and keeping in repair the public roads, highways, and bridges, including road drainage, road safety warning and road illumination.
43. **L13-297 - Rapides Parish Police Jury, Fire Protection District No. 11, Service Area No. 1** - 53.72 mills tax, 10 years, 2015-2024, (1) constructing, operating and maintaining fire protection facilities and (2) paying the costs of obtaining water.
44. **L13-285 - Sabine Parish School Board - (1) Many School District No. 34** - Not exceeding \$17,225,000 General Obligation Bonds, not exceeding 8%, not exceeding 20 years, (a) acquiring and/or improving lands for building sites and playgrounds, including construction of necessary sidewalks and streets; (b) purchasing, erecting and/or improving school buildings and other school related facilities and (c) acquiring the necessary equipment and furnishings; (2) **Sales Tax District No. 1** - ½% sales tax, 15 years, beginning January 1, 2020, (a) constructing, improving, operating and maintaining public school buildings and facilities; (b) acquiring equipment and furnishings and (c) funding into bonds.
45. **L13-254 - St. Helena Parish Police Jury, Fire Protection District No. 3** - 5 mills tax, 10 years, 2015-2024, (1) acquiring, constructing, improving, maintaining and operating fire protection facilities and equipment and (2) paying the cost of obtaining water.
46. **L13-258 - St. John the Baptist Parish Law Enforcement District** - ¼% sales tax, 10 years, beginning January 1, 2014, (1) operating and supporting the Sheriff's Office, including paying salaries and benefits of current and any additional law enforcement personnel, (2) acquiring technology and equipment enhancements, (3) providing capital improvements and (4) funding into bonds.
47. **L13-319 - St. Mary Parish, Recreation District No. 1** - 3 mills tax, 10 years, 2014-2023, maintaining, operating and improving recreational facilities.
48. **L13-288 - Tangipahoa Parish Council** - 0.50% sales tax, 30 years, beginning January 1, 2014, (1) renovation and enlargement of the existing Parish jail (or replacement with a new facility if more cost effective to do so); (2) maintenance, operation, staffing and the housing of Parish and municipal prisoners in accordance with a cooperative endeavor agreement between the Sheriff's Office and the Parish; (3) funding into bonds and (4) any surplus allocated as follows: (a) 50% to the Sheriff for purposes directly related to law enforcement and (b) 50% to the Parish for expenses related to the courthouse and criminal justice system.
49. **L13-255 - Tensas Parish Communications District** - 3.0 mills tax, 10 years, 2014-2023, acquiring, constructing, improving, maintaining and/or operating an enhanced 911 telephone system, including the payment of indebtedness incurred or to be incurred to provide facilities and/or equipment.
50. **L13-305 - Terrebonne Parish, Recreation District No. 7** - 9.50 mill tax, 10 years, 2014-2023, acquiring, constructing, improving, maintaining and operating recreation facilities, including the purchase of equipment.

51. **L13-306 - Terrebonne Parish, Recreation District No. 8** - 9 mills tax, 10 years, 2015-2024, acquiring, constructing, improving, maintaining and operating recreation facilities, including the purchase of equipment.
52. **L13-287 - Vernon Parish Police Jury, Road District No. 7** - (1) 7.38 mills tax, 10 years, 2015-2024, maintaining Parish roads and bridges; (2) 2.95 mills tax, 10 years, 2015-2024, constructing and improving Parish roads and bridges.
53. **L13-324 - Winn Parish Police Jury** - 1% sales tax, 10 years, beginning March 1, 2014, (1) 60% to the Parish for first, (a) constructing, acquiring, maintaining, improving and operating a solid waste collection and disposal system and (b) balance of proceeds for maintaining and supporting the Courthouse and providing other Parish services and (2) 40% to the City of Winnfield for (a) providing solid waste collection and disposal, including the operation, maintenance and improvement of its Waste Compaction Station, and (b) for providing other municipal services.

**OTHER BUSINESS**

54. **L13-320 - Lafayette Parish, City of Youngsville** - 4% Hotel/Motel Occupancy Tax, to be levied in perpetuity, beginning January 1, 2014, construction, maintenance and operation of a multipurpose community center, economic development and tourism.
