LOCAL GOVERNMENTAL UNITS - ELECTIONS (April 5, 2014)

3. **L14-016 - DeSoto Parish Police Jury** - 1.5 mills tax, 10 years, 2014-2023, maintaining, operating, and improving animal control facilities and mosquito control facilities.
4. **L14-021 - Iberia Parish, Village of Loreauville** - 5 mills tax, 10 years, 2015-2024, improving, maintaining, and operating sewerage works.
5. **L14-002 - Jefferson Davis Parish, Town of Welsh** - ½% sales tax, 10 years, beginning July 1, 2014, supporting, acquiring, constructing, improving, maintaining and operating the recreational grounds, facilities, equipment and programs of the Town.
6. **L14-017 - Lafourche Parish, Recreation District No. 2** - 3 mills tax, 10 years, 2015-2024, acquiring, constructing, improving, maintaining and/or operating the recreational facilities, including necessary equipment.
7. **L14-023 - Livingston Parish Council, Special Taxing District No. 5** - ½% sales tax, 10 years, beginning August 1, 2015, (1) acquire drainage works, equipment and facilities necessary to construct, maintain and operate outlets for the waters of the District and prevent flooding and (2) fund proceeds into bonds.
8. **L14-022 - St. Bernard Parish, Hospital Service District** - 30 mills tax, 1 year, 2014, (1) providing health care services and (2) equipping, maintaining and operating hospital facilities.
9. **L14-001 - Vermilion Parish Police Jury** - (1) **Parishwide** - 3.26 mills tax, 10 years, 2015-2024, maintaining and keeping in repair public roads and highways; (2) **Road District No. 1** - 5.72 mills tax, 10 years, 2015-2024, maintaining roads; (3) **Road District No. 4-A** - 6.93 mills tax, 10 years, 2015-2024, maintaining roads; (4) **Road District No. 6** - 6.27 mills tax, 10 years, 2015-2024, maintaining roads; and (5) **Road District No. 2, Sub-Road District No. 1** - 5.06 mills tax, 10 years, 2015-2024, maintaining roads.
